

DEED OF TRUST

2011 This deed of Trust is made on 21st September, 2011 Between 1. AMARENDRA NATH CHATTOPADHYAY, S/o- LATE ANADINATH CHATTOPADHYAY by faith Hindu, by calling a retired Teacher resident of Vill + P.O- Palashipara, P.S.- Tehatta, Dist- Nadia, 2. AMRIK CHATTOPADHYAY son of AMARENDRANATH CHATTOPADHYAY by faith Hindu, by occupation - social worker, resident of Vill + P.o. - Palashipara,



P.S. - Tehatta Dist- Nadia, hereinafter jointly called the settlors (which expression shall unless excluded by or repugnant to the subject of context be deemed to include their heirs, executors, administrator, assigns and representative) of the OTHER PART.

- 1. SRI AMARENDRNATH CHATTOPADHYAY, S/O- Late ANADINATH CHATTOPADHYAY by faith Hindu, by profession a Retired Person, resident of vill & P.O. Palashipara, P.S- Tehatta, Dist- Nadia
- 2. SRI AMRIK CHATOPADHYAY, S/O- AMARENDRANATH CHATTOPADHYAY by faith Hindu, by profession Social worker, resident of vill & P.O. Palashipara, P.S- Tehatta, Dist- Nadia
- 3. SRIMISHATABDI CHATTOPADHYAY, W/O- AMRIK CHATTAPADHYAY, by faith Hindu, by profession House wife resident of vill & P.O. Palashipara, P.S- Tehatta, Dist- Nadia.

Hereinafter jointly called 'TEH TRUSTEES' (which expression shall unless excluded by or repugnant to the subject and context be deemed to include the trustees for the being of these present and or survivors or any of them and their successor of successors in office) of the OTHER PART.

WHEREAS the Settlors are desirous of creating an endowment by settling apart and establishing a Trust Rs. 50,000(fifty thousands) object and purpose hereinafter, expressed.

The Trustees have at the request of the Settlors agreed to act as Trustees to these presents upon the terms and provisions thereinafter contained, and the Trustees have consented to act as the first trustees of the said trust.




- 1) The Trust created hereby shall be called Nadia Educational Trust (N.E.T.)
- 2. The Settlors hereby, hand over to the Trustees and / of Trust Board the assets for the purpose hereinafter contained and the said properties vests with the Trustees/ or Trust Board and to hold and possessed of the properties and any other sums of money, assets, donations, properties movable or immovable effects or contributions received by them hereinafter and by declarations there to and thereon and the investment including immovable properties and securities and from time to time representing the same hereinafter referred to as the Trust Fund for the promotions and encouragements of the need and purpose of the Trust.

AIMS AND OBJECTS:-

- i) The objects for which the trust has been created is for the purpose of promoting education and also for the welfare of education of the students. The activities of the Trust shall be aimed at improving and developing the living condition and general welfare of the needy students and in any other object of like nature to be determined by rules by not involving any activities for profit but for the welfare of the poor and needy persons.
- ii) To import, Promote and spread education and vocational training to young boys and girls as well as adult citizen in educative and vocational pursuit and for the development of the character, so as to produce law abiding, fearless and healthy citizen.
- iii) for the purpose of aforesaid to fund, maintain, organize, run manage, supervise superintend co- ordinate, officiate, control, guide and aid school, hostels, boarding hall, library and educational institution, as Primary, Secondary and Higher studies IN ALL STREAMS. All such institution, organization, establishments will bear the name of Nadia Educational Trust (N.E.T.)- in part





and will be maintained (exclusively) by the same Trust (economically, administration wise and / or otherwise)


- iv) to grant stipends, scholarships, free-studentship and other allowances, concessions or gratuities to the deserving students and candidates as and when necessary out of the general fund of the said Trust.
- v) To engage teachers, professors, constructors and experts of good moral character and to conduct to import efficiently and economically up to-date instructions to pupils and students of modern sciences, industrial location, research work, intellectual and other useful purposes.
- vi) To develop a healthy as well as critical attitude towards the development or mental, physical and moral uplift of the students and all those connected with the institution so as to make them good citizen.
- vii) To establish, maintain and run a boarding house and residential institution for the students and those connected with the institutions.


OFFICE OF THE TURST:-

The office of the Trust shall be situated at the house of Amarendra nath Chattopadhyay, P.O. + Vill- Palashipara, P.s- Tehatta, Dist- Nadia at such other place as the turstees by resolution of the Board of Trustees may decide from time to time.

TRUST FUND :-

The Trust fund shall include besides the amount received for the trust purpose and the trustees shall hold the capital and the income of trust fund for the purposes of the trust hereby accrued both movable and immovable properties in any manner whatsoever.






THE BOARD TRUSTEES :-

- 1) The Trustees shall form a Board of Trustees, which shall consist of not less than 3(three) and not more than 9(nine) persons.
- 1) AMARENDRA NATH CHATTOPADHYAY- CHAIRMAN.
- 2) AMRIK CHATTOPADHYAY SECRETARY
- 3) SHATABDI CHATTOPADHYAY- TREASURER
- 2) During his tenure as Chairman if he feels uneasy of physically ill or to be free form burdensome responsibilities he may have to think to have a free form tension or a normal and peaceful like by leaving the post of Chairman. The vacancy so raised be filled up immediately by election from amongst the trustees of members by the Board.
- 3) The Trustees shall have the right to remain in the board with the consent of all other members or they desire to leave the Trust as and when necessary i they fill physician illness or to have a normal life.
- 4) The Board of Trustees shall be entitled to nominate any person, to fill up the vacancies in the board of trustees, (provided however, if the total number of trustees falls below the number of 5, then the remaining or existing trustee shall elect any person to be a trustee) within a period of 30(Thirty) days form the date of vacancy of in an extended date.
- 5) A Trustee shall cease to be a Trustee of the Trust, If he resigns or if he takes up a citizenship of any other country other than India or for his moral turpitude of is guilty or committing offence if he is punished by a Court of Law.




1) The board of Trustees are authorized to accept and received for any property of any nature whatsoever which may be given to the trus for the purpose of achieving its aims and objects.






- 2) The Board of Trustees may receive grants, donations, aid granted by both Indian and foreign Nationals or any support or any type or subsidies granted by Govt. or non-Govt. organizations, financial assistance or otherwise both in India or form abroad including statutory bodies, Governments, Corporations, Universities and other public bodies and all this grant, donations, aids or any sort of financial assistance, either in the form of kinds and coins shall constitute the corpus of the fund to be used for the purpose of the Trust.
- 3) The Board or Trustees shall be entitled to acquire by purchase, lease, mortgage, loan, gift grant, legacy, bequests, exchange, right, privilege or otherwise from any person, company, society, Government or institutions of any body whatsoever, movable and immovable properties of all descriptions, including agriculture lands, such properties shall include those acquired by the Trust or by the Trustees in the name of the Trust of for and on behalf of the Trust of standing in the name of the Trust or held in the name of the Trust of held in the name of the trustees or any of them.
- 4) The board of trustees are further empowered at their discretion to sell, lease, mortgage, alienate, or otherwise, transfer any of the trust properties in such manner and on such terms and conditions as the board of trustees may deem fit and proper but just by an unanimous, resolution of Board Trustees.
- 5) The board of Trustees shall be entitled at their discretion to raise and repay loans, with or without security in any manner the Board of Trustees may deem fit and proper.

6) The Board of trustees may at their discretion employ all the trust monies or any portion thereof or any other property in such manner as they deem fit for the betterment of the Trust and they may for this purpose acquire properties of any nature whatsoever, including agricultural, industrial, commercial, manpower development and research including rural or otherwise or to establish institute, organize, conduct, promote, control, maintain, equip, develop, manage, administer or dispose of any institutions in any manner whatsoever for the purpose of attaining the aims and objects of the Trust.







the trustees, The Chairman shall also be entitled to delegate such power, duties and responsibility to any person of persons appointed for the purpose of purposes other than trustees.

- 16) The board of trustees are empowered to appoint and remove a committee of committees with appropriate titles for the purposes of management and administration and execution of the trust or any activities thereof. Such committee (s) shall dunction under the board of Trustees and within the limit of powers, rules and regulations laid down form time to time by the Board of Trustees.
- 17) The Board of Trustees may appoint and remove character accountants, secretaries, auditors and such other person or persons of officials as may be necessary for the purpose of proper management, administration and maintaince, allowances and/of emoluments as they may deem fit and proper.
- 18) The Board of Trustees are empowered to initiate proceeding, to compromise, compound, abandon, withdraw or refer arbitration any actions, proceedings or disputes claims, demands of things relating to any matter in connection with the Trust and to do all other things proper for such purpose without being responsible for any loss occasioned there by.
- 19) The Board of Trustees shall have the right to enter into agreement for and on behalf of the Trust. They will have the right to make contracts honour the same on behalf of the Trust. For entering into a contract, signature of the secretary of the Trustees Board with one or move more Trustees will be sufficient and shall bound the Trust.
- 20) The Board of Trustees shall invest the funds of the Trustees only in the modes specified under the provisions of the income Tax Act, 1961.
- 21) The Board of Trustees shall be entitled to amend, and rectify any clauses of this Trust Deed to remove any difficulty that may arise for the proper conduct of its activities and or to being about any improvement of achieve the aims and objects of the Trust. However, no amendment shall be made which


may prove to be repugnant to the provisions of the Income Tax Act and further no amendment shall be carried out without the prior approval of the commissioner of Income Tax.

- 22) The Board of Trustees shall ensure at all times that the funds and income of the Trust be solely utilized towards the achievement of the objects and aims of the trust and no portion of it shall be utilized for payment to Trustees by way of profit, interest, dividend and remuneration, provided however the Board of Trustees are empowered to reimburse to themselves expenses validly incurred for the purpose of the Trust.
- 23) No Trustee shall be liable for any bonafide action taken by him in respect of any matter of the Trust.
- 24) The Trust shall sue of be sued in the name of The Chairman.
- 25) Appointment of non-teaching employee/ clerks, peons, darwan ect. The Trust shall have the right to appoint all these persons through a Selection Committee made by the Board as and when necessary by making resolutions in a Board Meeting.

Provided however, no Part of the income thereof be applied to any purpose outside India except in accordance with the approval of the Central Board of Revenue, Government of India.



- 9) The Board Trustees shall from time open and maintain bank Account or Accounts in the name of Trust in any Nationalized Bank or State Bank of India or any Schedules Bank or Co- op. Bank and the said Account shall be operated by the Chairman with one/ two other Trustees duly authorized by the Trustees Board in a Meeting.
- 10) The Trustees shall maintain proper accounts, the receipts and disbursement relating to the Trust property hereby created and shall have such audited and the Trustees shall pay audit fees if any out of the income if Trust.
- 11) The Board of Trustees shall drame their rules and regulations not inconsistent with the terms and conditions here of for the efficient management and administration of the trust and to add to, amend, after, or delete such provisions as required form time to time as they may deed fit and proper.
- 12) The board of Trustees may also lay down guidelines for their own conduct and procedure with regard to their meetings, and management and administration of the Trust. The meeting procedure and its conduct be followed as per rules and guidelines of meeting.
- 13) The Trustees will have the power to give and take loans form any person or institutions of both Indian and Foreign Nationals and the use of such loans will be in their sole discretion consistent wholly with the purpose of the trust. Further they will have the right to purchase of any other assets both movable and immovable sale or mortgage and / or hypothecate the trust property for the furtherance of the activities of the trust.
- 14) All resolutions of the Board of Trustees shall be approved by the Chairman of the Trust and any resolution passed in he absence of the chairman shall be void and have no effect.
- 15) All documents, chaques, instruments, receipts of the Trust, other than purely of routine nature shall be signed jointly by the chairman and one of two Contd....
